SUBJECT: Pool Chemicals Bid

The bids for a three year contract for pool chemicals were opened on March 15. Bidders were required to provide chemicals consistent with the chemical system at Samford Pool. Aquatic Consulting and Equipment was the sole bidder with an amount of \$80,585. This breaks down to \$26,070 for the first year, \$26,855 for the second year and \$27,660 for the third year.

It is recommended that the contract with Aquatic Consulting and Equipment be approved.
