SUBJECT: May 2022 Tree Removal and Pruning

We solicited bids from area contractors for the cost of labor, equipment and material necessary to complete the May 2022 Tree Removal and Pruning project. The following bids were received:

The work includes the removal of eight at-risk trees at various locations within the City and pruning of trees at four different locations within the City. Tree Risk Assessments have been performed based on the City's approved Tree Risk Assessment Program and the risk rating for each tree indicates imminent or probable likelihood of failure.

I recommend awarding the contract for the project to Tiger Tree Experts Inc., dba Halls Trees Service for \$22,500.
