Resolution authorizing the City Manager to execute a contract with Sign World Inc. for the procurement and installation of master wayfinding for the Douglas J. Watson Municipal Complex. The wayfinding package also includes directional maps of the complex and other nearby City Facilities such as City Hall and Felton Little Park.
