RE: Purchase of three police motorcycles

I am recommending the purchase of three (3) 2024 Harley-Davidson Electra Glide police motorcycles. One of these motorcycles is a replacement for unit 168, a damaged 2016 Honda ST1300. Two of the motorcycles will be expansion vehicles that are needed to support special events and traffic enforcement. An invitation to bid was publicly advertised on May 20, 2024. One responsible bidder, Momentum Holdings d/b/a Redstone Harley-Davidson, submitted three bids. The cumulative cost of the vehicles will be \$83,655.66 based on the provided quotes, which includes all upfitting of emergency equipment. This vendor can provide parts and service for the upkeep of these vehicles.

A FY24 budget adjustment has been requested to support this purchase. The vendor will have the vehicles available for delivery 45 days after the receipt of a purchase order.
