Over the last few years, we've been expanding the amount of parking in downtown Auburn to give everyone a place to park as they go downtown to visit, shop, dine or head to Auburn University's campus. With the addition of the Wright Street Parking Deck last year, we now have more than 1,300 public parking spaces.

Here are some reminders as you visit downtown this fall:

#### WHERE CAN I PARK?

The Wright Street Parking Deck (140 Wright St.) has 350 parking spaces that are open to the public year-round. This is the closest parking for those heading to Auburn University's campus. Parking is charged by the hour — no monthly or other parking passes are available.

All surface parking spaces are limited to two-hours and are available in the Gay Street Parking Lot, on the ground floor of the Municipal Parking Deck, in the Tichenor Avenue Parking Lot and along the street on Magnolia Avenue, College Street, Gay Street, Tichenor Avenue and Wright Street.

#### **HOW MUCH IS PARKING?**

Surface parking is \$1 per hour (up to two hours) Monday through Friday from 8 a.m.-6 p.m. Surface parking is free after 6 p.m. and on weekends, as well as on City holidays and during breaks between Auburn University semesters

Parking in the Wright Street Parking Deck is \$1 per hour 24/7 (with a limit of \$15 per 24-hour period). Special rates may apply on Auburn University's home football game days.

#### **HOW CAN I PAY FOR PARKING?**

Those using surface parking may pay using one of the parking kiosks throughout downtown or through the ParkMobile app. Those parking in the Wright Street Parking Deck may pay using the walk-up kiosks inside the deck or at the exit gate.

## Fall Household Hazardous Waste Collection Day

Environmental Services will host its biannual Household Hazardous Waste Collection Day on Saturday, Oct. 22. Auburn residents are invited to drop off materials from 9 a.m.-1 p.m. at the Environmental Services Complex at 365-A N. Donahue Drive


During the event, the department will accept hazardous waste not collected in regular garbage and trash pickup. Computers and electronics will be accepted as well as paper documents for secure, onsite shredding. Residents may bring up to 20 pounds of material per household for disposal at no charge.

Those participating in the event are asked to register ahead of time by filling out the form at auburnalabama.org/HHW. On the day of the event, participants should load the materials they wish to dispose of in the trunk or rear of their vehicle and enter the Environmental Services Complex via North Donahue Drive. Once participants have arrived, workers will remove the materials from vehicles.

Participation is limited to Auburn residents, and proof of residency can be shown by bringing a recent water bill. A list of acceptable materials can be found at auburnalabama.org/environmental-services/household-hazardous-waste-collection-day.



Auburn's newest playground opened in June with the goal of giving all — regardless of age or ability — a place to play, together. The more than 60,000-plus-square-foot playground is nestled between Wrights Mill Road and Camellia Drive at 430 Camellia Drive. The playground has more than 30 play structures in five large pods that are designed for different age groups, ranging from infants to adults.



Many of the benches were installed off-center to allow room for someone in a wheel chair to pull up and sit beside someone on the bench. Some of the picnic tables have space for a wheel chair to pull up to the table as well. There's equipment throughout the park that allows those in a wheelchair to easily transfer on and off, and there are several sensory components throughout the park, including a shaded sensory maze with textured panels. The playground includes accessible fitness equipment stationed alongside a Ninja Fit course, and a quarter-mile loop walking trail surrounds the equipment.

## Door-to-door soliciting regulations

Do you ever wonder if that door-to-door salesperson is permitted? Under section 16-29 of the Auburn City Code, a solicitor must be registered with the City of Auburn prior to going door-to-door. Each registered solicitor must have a photo ID permit badge as evidence of having registered with the City's Revenue Office.

Solicitors are given the following guidelines by which to abide while they are conducting business in Auburn:

- If any home or neighborhood displays a "No Soliciting" placard, solicitors must discontinue any efforts to solicit and may not leave any literature concerning the solicitation at that residence or in that neighborhood.
- Any solicitor who is asked to leave any residence by the occupant shall immediately and peacefully depart.
- Every solicitor shall carry a permit in plain sight while soliciting within City limits. The same shall be visible about the body of said solicitor so as to be seen by any police officer or by any person who is solicited.

Solicitation is permitted during the following hours only:

- September through May: 8 a.m. to 6 p.m.
- June through August: 8 a.m. to 8 p.m.
- Sundays year-round: Noon to 6 p.m.

No door-to-door solicitation shall be conducted on City holidays.

## WHAT'S ALLOWED IN AUBURN'S CEMETERIES?

To ensure their beautification and proper maintenance, only certain items may be displayed in Auburn's cemeteries. Please keep these guidelines in mind when honoring loved ones.

Prohibited items include benches, settees, urns, boxes, shells, toys, fences, solar lights, large pots/planters, wind chimes, statues, yard art, and any item that interferes with lot maintenance.

Outside of designated holidays, flags may only be displayed as part of a floral arrangement. Only U.S. flags may be displayed separate from floral arrangements on Memorial Day, Independence Day, Flag Day and Veteran's Day. Flags should be placed centered next to markers one week prior to the holiday and should be removed within one week after the holiday.

Floral arrangements should be placed next to markers. Flower saddles are allowed on upright markers at Pine Hill and Town Creek cemeteries.

Maintenance crews will remove prohibited items from each cemetery every six months, and notice will be posted at the cemeteries at least one week before the cleanup is scheduled.
